# 2018 Annual General Meeting

# August 25, 2018

# 1. Welcome and Introductions:

Ken Grant called the meeting to order, and welcomed everyone in attendance. He introduced the 2017-18 Board of Directors, (Donna Commerford – Vice President, Debbie Bird- Treasurer, Greg Best – Secretary, David Cox – Road Manager, North Shore, Murray Finch – Road Manager, South Shore, Keith Rowe – Member-at-Large and Steve Burnie, Member-at-Large. Ken informed members that this would be his last meeting as Association President and that Donna Commerford has agreed to let her name stand as President for the coming year.

# 2. Review of 2017 AGM Minutes:

Minutes of the 2017 AGM were presented and reviewed.

It was moved by Jack Commerford, seconded by John Fenton and subsequently carried:

**3. Cottagers: Memorials** – a moment of silence was held in memory of Mary Frick, George Tubbs, Ron Veley Don McIlveen, and Ed Braunsdorf.

New Arrivals – Ken Grant welcomed Bill Egan and Lynne and David Marsh to the lake.

### 4. Directors' Reports:

**Vice-President** – Donna Commerford reported on annual events on the lake, thanking all event organizers and participants. The Kids' Fishing Derby was very successful. The Triathlon and Golf Tournament did not take place this summer but will be on again next year. The Sail Boat Race will take place on Sunday of the August long weekend

Donna also thanked Area Representatives for their work this year.

In addition, Judy Pietrusiak was recognized and thanked for her work on the BGLEECA Calendar.

**Treasurer** – Debbie Bird provided printed copies of the budget and financial reports for the year, providing a brief explanation of each. This was followed by questions and some discussion.

Ken Grant read a statement from Robert Jelking who has completed a review association finances from August 1, 2017 through July 31, 2018. (attached)

**North Shore Road Manager** – David Cox reported on the North Shore Road meeting of August 18. Speed limits have been adjusted on some north shore cottage roads.

The annual road fee will remain at \$200.

David also informed the meeting that a water weed cutter is available from the Association for a nominal rental fee.

**Environment (Lake Steward)** – Ken Grant reported that water quality sampling has been on-going. He provided an overview of the Lake Partner Water Quality and Water Rangers programs.

There was discussion about control of Eurasian Millfoil, an invasive species of weed found in the lake. Cottagers from neighbouring lakes are approaching municipal officials for assistance in controlling the Milfoil. It has been present in Big Gull Lake for a number of years.

Thirty-two cottages participated in the tree planting project this year. Trees were provided through the Mississippi Valley Conservation Authority.

There was discussion about this year's infestation of tent caterpillars and gypsy moth caterpillars. Next year, the Association will make "Gypsy Moth Kits" available to cottagers.

The 2018 Lake Links workshop will be held in Perth on October 20<sup>th</sup>. Association members were encouraged to attend.

**Directors at Large** – Keith Rowe reported that this year's Kids' Fishing Derby was a success with thirty-two participants. He thanked who participated or volunteered in making the day a success.
