Incident on Ardoch Road north of Greer Rd, August 30, 2019

A man was robbed at night after being stopped by a vehicle with flashing emergency lights.

If you think this is happening to you, the advice from OPP is not to stop if it is an unmarked vehicle. Put 4-way flashers on and slow down a bit so if it is an officer they will know you are not trying to flee. Call 911. If you are in an area without a cellular signal (eg. some spots on Ardoch Road) keep driving until you get cellular service. The 911 staff will confirm if it is an officer behind you. You can also request that another cruiser

be sent if you are still uncertain that the car with flashing lights behind you is legit, whether marked or not.

NOTE: This course of action would not be acceptable in an urban area where you would be expected to pull over. If the car with flashing lights is bogus and tries to run you off the road (ie. late at night, isolated), find a house with lights on and pull into the driveway with horn blaring. Do not pull into a drive of a house with no lights on as then you could be cornered.

Lake Steward Report for Jan 31, 2020

I attended the FOCA Fall Seminar in Toronto. Highlights included a review of hydro rate increases, septic system re-inspection strategies, concerns with noise and boat speed, and a growing concern on how to control the negative impacts of Air B&B growth in cottage country. Some municipalities have initiated a mandatory registration program including a system of fines to control numbers, parties, noise, etc.

On a more local note, the North Frontenac Lake Alliance Association initiated a study of the North Frontenac Septic Re-Inspection Program which has been running since 2005. Questions include: is the program working, are we identifying problem systems, how many cottagers refuse the free inspection, how long will it take to complete the program? The intention is to share the data with individual lake associations and with the municipal council with a view to ensuring we are spending tax dollars in a cost-effective way and identifying and replacing faulty septic systems. The goal is to ensure that we do all we can to protect the water quality in our North Frontenac lakes.

As your lake steward and as a representative of the North Frontenac Lake Association Alliance, I have been asked to represent seasonal residents on a Public Advisory Committee for a study of the Mississippi River Watershed. We met this past fall and winter to review position papers on the watershed: The Physical Environment; People and Property; Natural Systems and Asset Management. The end result will be a discussion paper outlining the vision and expectations for the watershed. This will be shared with the Policy and Priorities Committee and Council of the Mississippi Valley Conservation Authority before being released to the public via a series of information meetings.

Some of you will be interested in a media release from Watersheds Canada concerning pollution related to plastics: question - does it affect lakes in North Frontenac?

November 5, 2019 -- Summer sampling in three local watersheds determined that out of 270 samples from 9 inland lakes studied, artificial materials (including fibres, fragments, and plastic film) were present in more than 90% of samples. "We know that this is an issue in our oceans and large bodies of water but we wanted to know if microplastics were also a huge issue in our smaller freshwater lakes that have private sewage systems and no commercial wastewater treatment plants" said Barbara King, Executive Director of Watersheds Canada. "Frankly, our findings were quite shocking considering we were finding microplastics in 90% of our samples, which were taken only in the top 1 litre of surface water". A variety of lakes were sampled including both urbanized environments and more secluded, less developed portions of each lake. "What we thought would be a relatively microplastic-free lake (a clean, spring-fed lake with no public access and only 22 residential properties) still came up with an average of 3 microfibrils per 1 litre of water sampled!", said Barbara.

We continue to sample water quality in Big Gull. Virginia Grant and Bev Williams collect water samples in the spring. They also measure the phosphorous levels using a secchi disc through the season. These results are sent to the Water Shed Watch program run by the province and FOCA. Virginia also conducts sampling for the Water Rangers program on a weekly basis: sampling includes dissolved oxygen, surface and air temperature, conductivity and pH levels. Kid's Fishing Derby- SATURDAY AUGUST 1, 2020

We had another beautiful sunny morning last year for the kids fishing derby. Our prize table was bursting with goodies from our sponsors, and our grill man Steve Burnie was cooking up hot dogs and crispy fish fillets. The fish cleaning station was in good hands with Bill Phyfers, Dave Toole and Ken Grant. Our cooking prep table was handled by Troy Rowe, who was battering fish fillets and keeping all the buns ready for hungry kids. Virginia Grant and her daughter were signing in our anglers, preparing the names on their participation certificates and packing up their take home kits. Our official weigh station was handled by Campbell Woodside, who was earning "community hours" for volunteering at our event.

The success of this event is all due to the volunteers who give up a Saturday morning once a year, to provide kids around the lake a non-competitive, fun family event.

Sadly, this event is suffering from declining turnout. Last year our registration was down 60% from the previous year. In 2017 we had 39 kids, 2018 we had 43 kids, 2019 only 18 kids.

The cottage association board of directors is not responsible for putting on this event. Four years ago the fishing derby was at risk of cancellation as the organizers dropped out at the last minute. The Board decided to step in and take over to be sure the event continued that year. Since that date, Keith Rowe has been the driving force behind the fishing derby for the past 3 years, but with regret, he has decided to step aside for 2020.

Keith is willing to continue to coordinate with our sponsors: Rapala Canada, Bob Azumi's Real Fishing Magazine and The Department of Natural Resources.
